

Instruction for Judges Registry Application

The Association is implementing the use of a Judges Registry, which is a database of approved Judges who are qualified at different grade levels, and who may be authorized to organize Ranking Events and Tournaments, to serve on Examining Committees, and to serve on the Judges and Ranking Advisory Board and on other committees pertaining to Judges and Ranking.

Ranking Event Examining Committee Judges are selected from the Judges Registry.

Application for Judges Registry

In order to be included, you must submit the Judges Registry Application form. The application is reviewed by and approved by the Judges and Ranking Department.

Everyone Rank Three or higher who has experience and/or training as a Judge in any Ranking Event may submit their names for inclusion in the Judges Registry.

The Judges Registry Application Form

1. Section One, Identification

Please fill out the form as completely as you can.

(As of January 1, 2012, criteria for Judges Grades have not yet been completed, so leave this space blank.)

2. Section Two, Judges and Ranking Experience

Include your resume of experiences as a ranking event Organizer, Head Judge/Presiding Judge, Scoring Judge, and other positions you have filled during a Ranking Event. Include as much information as you can. Don't worry if you are missing some information about the events you have participated in. Ask the Center Director or the Head Judge/Presiding Judge under whom you worked to help you. Each Center should have records of all its ranking events, and records are kept at the Association. The Judges and Ranking Department will receive your application and will attempt to authenticate and to complete your entries.

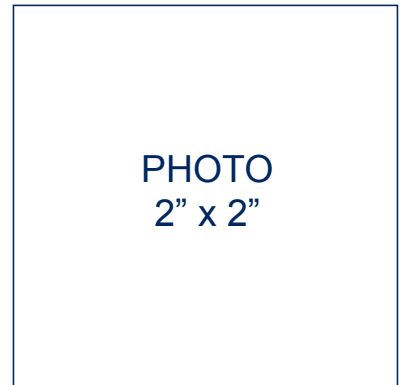
